Online and mailed entries will only be eligible for the Entry Period in which they were received. Entries received for any given Entry Period will not be entered into subsequent random drawings. Webhost's computer is the official time-keeping device for the sweepstakes.

- 5. RANDOM DRAWINGS:** One (1) winner will be selected for each Entry Period from among eligible online and mailed entries received for that Entry Period on/about the dates specified in the chart in Rule #4. Random drawings will be conducted by Blue Monde, LLC d/b/a Promotion Fulfillment Center. ("PFC"), an independent judging organization whose decisions are final. PFC will make one (1) attempt by telephone to contact a potential winner selected from the online entries to obtain a mailing address for prize fulfillment.
